Registration and packet pick up will also be available race morning from 7:00AM till 8:30AM at the Hopwood Vol. Fire Dept. Sweatshirts for the first 700 registered. TIME/RESULTS: The race starts at 9:00AM. Walkers will start 3 minutes following the start.

CEREMONY: The ceremony and pizza party will be held at the Summit Inn immediately following the race. You must be present or have someone pick up your award. **The Club does not mail awards or have pickup after the race.**

AWARDS:

- Runners/Walkers: Top 3 Male and Female Overall and Top 3 in Age Group. 5 yr. age groups, ages 15 thru 70. 14 and under and 70 and over.
- Cruisers (175-199 lbs): Top 3 Male, must weigh-in race day!
- Clydesdale (+ 200lbs): Top 3 Male, must weigh-in race day!
